

Terms & Conditions for Studydrive Content Upload Service

Use of Services

- These terms and conditions apply to students, 18 years of age or older, currently or previously enrolled in UK higher education.
- Participants have the chance to earn money by uploading their study documents.

Study documents dos & don'ts

- The participant is solely responsible for ensuring that their documents are compliant with legal requirements. The publishing of copyright protected illegal or indecent material is prohibited.
- Supported study documents are class notes, exam notes, summaries, essays, solutions, worksheets, practice tests and flashcards. Documents for which the uploader has been granted the right by the rights holder for use and public publishing on Studydrive are also accepted.
- Document splitting is not allowed. Content of the same teaching unit cannot be split into several documents. No document may be uploaded twice or in multiple modules.
- Entire books and articles as well as copyright protected documents are not allowed.
- Hand-written summaries require high quality photos and should be clear and legible.
- Supported document formats: pdf, doc, docs, jpeg, png, xls
- Study documents will be automatically screened and checked on a sample basis.

Registration

- The participant collects all documents from existing and previously attended modules and uploads them to cloud storage i.e. Google Drive, Dropbox, WeTransfer. Documents should be grouped according to the module they belong to. Documents that belong to the same module should represent one folder so that the number of folders represents the number of modules. The last step is to share the contact details and the link to the documents with Studydrive.
- Studydrive will review the material and offer the participant a fixed amount as payment for the documents as well as the option to choose to become a [Course Expert](#) instead of receiving direct payment for the documents. The participant can accept or decline the offers. With the acceptance of one of the two options, all rights to the documents are

transferred to Studydrive as outlined below under “Transfer of Content Rights” and the participant becomes eligible to the accepted payment conditions.

- Any submission must include the participant’s contact details.
- Entries not submitted in accordance with the rules or incomplete or illegible entries will be disqualified.

Payment

- Payment is on a per-course basis and Studydrive reserves the right to determine the payment amount depending on the quality of provided documents. Participants accept and acknowledge that they cannot derive any rights from the estimate.
- The payment is cashless. The final amount can be received in a direct payment via Paypal within 30 days of accepting the offer. In case a participant wants to become a Course Expert at Studydrive and continue earning money, the respective amount will be credited to the Course Expert’s account and will be paid at the end of their contract.

Transfer of Content Rights

- The participant assigns all rights to their uploaded study documents to Studydrive. This especially includes rights of use and exploitation, as well as the commercial distribution of material to third parties. The participant grants Studydrive the irrevocable, indefinite, non-exclusive, transmissible, entirely compensated, worldwide license regarding their content provided on Studydrive. This includes the use, copying, publishing, saving, transferring, and distributing of the content uploaded on Studydrive by the participant. The participant warrants that they own those rights and can assign them to Studydrive.

Data Protection

- All contract parties are obligated to comply with laws and regulations regarding data protection. They will especially bind their employees to comply with the data secrecy as per § 5 BDSG.
- There will be no transfer of personal information to third parties for advertising purposes.

Closing provision

- The legal recourse is excluded.
